Each board member is provided a copy in which the conflict of interest policy and requirements are written. Upon hire, election, or appointment, a full written disclosure of any direct or indirect conflict is required to be made by the individual. This written disclosure is kept on file and updated annually or as needed. If a conflict is identified, the member will not be permitted to participate in the transaction or the decision.</p>
